Snakes in the Estate.

A number of years ago this area was a farm, later on it became Grootvlei Gold Mine then, about 10 years ago became Grootvlei Residential Estate, with open fields surrounding the estate. Bearing this history in mind, we have now built or bought homes on what was the home of wild life. We have seen small buck outside the estate and have had a Bush Pig and Porcupine come through the estate, while we have rabbits, wild birds, rodents (rats & mice), reptiles (frogs & lizards) living in the estate. Snakes which hunt rodents and reptiles as

well as bird's eggs will naturally enter the estate on the hunt for food. If we give them place to live or a source of food, they will stay in the estate.



Not all snakes are dangerous, we have many nonvenomous snakes in our area, but always consider a snake as dangerous and do not fool with it.

So how do we minimise our chances of running into snakes in our gardens?

- Don't leave piles of rubble in your garden; this attracts rats, mice, lizards and provides snakes with place to live.
- ➤ Don't have a bird aviary in your garden; this provides eggs and living quarters for snakes.
- Keep your grass short: snakes hunt in the long grass (they don't need to see, they "taste" the air and feel vibrations).
- Remove garden refuse at least every week: again, this attracts rodents and reptiles and provides cover for snakes.

Be on the look-out for snakes when stepping outside during the day as they look for hot spots to rest in the sun. The warm weather during summer causes people to flock outside and enjoy the rays of the sun and cooling water of the pool.

This also means that snakes will now be around after a long period of hibernation. Until late May it is snake season, and the Ekurhuleni Metro wishes to caution pet owners to be on high alert and keep an eye on their domestic pets as they may fall victim to snakes.

Several snakes which are harmless to humans, such as the brown house snake, aurora house



snake, olive house snake and red-lipped snake are likely




to be found in back gardens searching for food such as rats Due to their harmless and less defensive nature, these species

of snakes tend to be easily killed or captured as











Meanwhile, snakes such as the Rinkhals and Stiletto are extremely dangerous. The Rinkhals, or ring-necked cobra, (common in Springs) is a fast-moving multi-feeder which is good at faking death, do not attempt to pick one up that looks dead.

It is easily identified by the two white stripes that are visible across its neck when it spreads its hood.

The Stiletto is purple-brown and only Ave 40cm long (max 70cm) with back fangs that strike out the back side of mouth, they do not look dangerous but handling them you WILL be bitten.

What to do when face-toface with a snake:

- Give the snake the right of way.
- You can scream and shout, but do not jump or move. Snakes eye site is poor, but they can follow movement.
- Keep about five metres from the snake, as some snakes can spit venom up to 3metres. (Rinkhals)
- Watch where the snake goes so you can assist in locating the reptile once an expert arrives.
- •Do not try to kill the snake, it may lead to you being bitten.
- Call for help. (Security, Office Clive or Louis)

What to do if bitten by a snake or spat in the eyes or an open wound:

- Do not panic.
- •Do not run or try to drive yourself.
- •Get medical attention as soon as possible. Most of the above pictures are thanks to Tyrone Ping

If Spat in the eye/s wash your eys out with lots of water. If pain resists, seek medical attention.

Grootvlei Residential Estate does have a snake catching kit, we do **not** have a snake bite kit, please do not try to attack or tease the snake, rather keep an eye on it from a distance, so you know where it is. Call and we will capture and place it back in the wild. Snakes have an important part to play in our eco system. Please don't kill the snake, the environment needs them.

Should residents come across snakes in their garden, they may contact Louis or Clive, but keep an eye on the snake so we know where it is when we arrive.

Many residents on Phase 2 & 3 side have fenced gardens and own dogs, the house rules do also make provision for the owning of pets.

We have a number of dogs that bark all day and some that bark all night and a few that bark both day and night.

We have recently had numerous complaints regarding the endless barking and request that owners train their dogs, (privately or by dog training schools) as the persistent barking becomes a nuisance to other residents.

Some residents work long hours or shifts and do need to get their rest.

Please consider your neighbours.

Non-Compliance levies will be issued if dogs roam streets or bark continuously.

This could be your advert.

An extract from the house rules



K.- Pets

- 1. The local authority by-law relating to pets will be strictly enforced.
- 2. Residents may not keep more than two dogs or 2 cats on their property without written permission of GREHOA.
- 3. Pets are not allowed to roam the streets and dogs must be kept on a leash, in all areas, at all times.
- 4. Should animal excrement be deposited in a public area, the pet's owner shall be responsible for the immediate removal thereof.
- 5. The GREHOA reserves the right to request the owner to remove his pet should it become a nuisance on the estate.

Around the Estate, some rules and by-laws you need to remember.

Swimming Pool.



Another ladder has been fitted at the shallow end of the pool making it easier for residents to exit the pool. Previously this year we installed a ladder at the deep-end and floatation devices for emergencies. The swimming pool was open for the Festive Period, and enjoyed by many, with almost everyone



complying with the pool rules. If you are the one not complying, REMEMBER, YOU are in the minority and we will take action against you.

Pool is closed for maintenance on Mondays except when Monday is a public holiday, Hours 08H00 to 18H00 daily. Please don't play with the Safety Equipment (Floatation Devices) or the pool cleaning equipment (creepy and pipes). We will take action against persons playing with this equipment. The pool area is monitored by 24hour camera surveillance.

Grass cutting.

Owners/Residents are responsible for the cutting of the grass on their stand and pavement up to the road. We have several owners/residents who are not cutting their grass. This not only causes serious issues like, insect and rodent



infestations, which attracts snakes, but is unsightly for your neighbours and people visiting the estate.

Keeping your stand neat and tidy is not negotiable, if you do not keep your garden in order, first a written waring is issued, then a R250.00 non-compliance



the same day or latest next day, as the levy was issued, not 5 days later after you have cut your grass.

Burning of garden refuse and domestic rubbish.

It is illegal to emit dark (thick) smoke in Ekurhuleni, this means you may not burn your rubbish unless you have a temporary exemption from the by-law (151).

Extract from the Ekurhuleni by-laws: -

- 151. (1) Subject to section 146(2), no person shall emit or permit the emission of dark smoke from any dwelling for an aggregate period exceeding three minutes during any continuous period of thirty minutes.
- (2) Any person who emits or permits the emission of dark smoke in contravention of subsection (1) commits an offence.
- (3) Subject to section 188 and on application in writing by the owner or occupier of

any dwelling, the Council may grant a temporary exemption in writing from one or all of the provisions of this Part.

If you burn any rubbish and we receive a complaint, we will have no option, but to take action against you, please take your refuse to the Metro Dump sites in Geduld

or Daggafontein or to the Rietfontein waste site at Kwa-Thema.

Do not dump along the roads outside the Estate (like the guy in the picture), if caught, you will receive a R2000.00 fine from Metro Police.



House Rules and Regulations.

Before we moved in, we all agreed to and signed a set of house rules. These rules are designed for the safety of all residents. If you have misplaced your copy we are more than willing to send you a copy, please read them. House Rules are being revised at the moment.

An extract from the House Rules Document:

- 1. Harmonious community living is achieved when residents use and enjoy their private property as well as the public areas of the Estate. General consideration of all residents by and for each other will assist greatly in assuring harmonious relations on the Estate
- 2. The prime objective of these Rules and Regulations is to preserve and enhance the security, aesthetics and environment of the Estate.
- 3. The Rules have been established in accordance with the Memorandum and Articles of Association of GROOTVLEI RESIDENTIAL ESTATE HOME OWNER'S ASSOCIATION (hereinafter referred to as GREHOA, a company incorporated in terms of Section 21 of the Companies Act 61 of 1973). These Rules are binding upon all occupants of the Estate, as is any decision taken by the Trustees in interpreting these Rules.
- 4. The registered owners of the properties at GROOTVLEI RESIDENTIAL ESTATE are responsible for ensuring that members of their families, their tenants, visitors, friends and employees abide by these Rules.
- 5. These Rules are subject to change from time to time at the discretion of the Trustees
- 6. The decision of the Trustees is final and binding in respect of the interpretation of these Rules

Please, these rules are there to ensure that you can live safely, in peace and harmony with your neighbours and the environment, abide by them, we do enforce them as per section L4 of the house rules

The Trustees have the right to fine transgressors where any of the rules as stipulated by the GREHOA from time to time, have been broken or infringed upon. Such fines will form part of the levy and shall become due and payable on the due date of payment of the levy.

We do impose/issue non-compliance levies. This can range from Verbal warnings, written warnings, or R250.00, R500.00 even R750.00 for repeated non-compliance

Fireworks.



Fireworks are very pretty with all the different colours and shapes they make, BUT, they are extremely hazardous. They cause fire, burn injuries, scare dogs into trying

anything to escape the noise and cause damage to human and even more so animal ears, for this reason most Metros have clamped down on the discharging of fireworks in the Metro areas, they have made provisions for certain religious occasions.

In the interest of the safety of all residents,

pets and wild animals living on the estate, the discharging of fireworks is ${\bf NOT}$ **PERMITTED**

Anyone discharging fireworks will be issued a non-compliance fine (R250 1st offence, R500 2nd offence) without any verbal or written warning. If need be we will call in the Metro Police to issue fines as well.

Last year we had dogs badly injured while trying to escape the loud bangs, I even witnessed a person setting off fireworks right next to a baby in a pram, and while talking to a resident in phase 1, I watched his daughter who was holding one of those long tube-like fireworks, she lowered her arm to listen to me while the

fireworks were still shooting out of the tube, but now all shooting against her father's Mercedes Benz standing in the driveway. I do not know if any damage was caused to the vehicle, but that could have been pointed at a person and serious injuries could have occurred.

Parties.

We all enjoy a good party and we all would like to invite our friends to a party at our home.

This is not a problem at all if it is done in such a way as not to cause undue disturbance to your neighbours or any other residents in the estate.


Please inform the office if you are going to have a large number of vehicles coming into the gates.

- The office can, under certain circumstances, arrange a temporary entry/exit pin code instead of each guest having to phone in, Ts&Cs apply.
- Please inform your guests of the speed limit (30Kmh), as we can, and do, escort speedsters off the property and/or issue you with non-compliance levies, one per speeding vehicle.
- Please ask your guests not to wonder around the complex as this causes an issue with security, as we do not know who is legally

on the estate and who has gained entry illegally.

- ❖PLEASE, from 7 PM, start to turn your music down so that by 10pm it is soft enough not to be a nuisance to your neighbours. Complaints are attended to.
- It is not necessary to have music so loud that it is heard from many houses away.





- Some residents have 12 hour and longer days, to get to work and work then return home. Please consider those around you.
- •We all purchased property in the estate because we saw how peaceful and safe the environment in the Estate is,

you would feel, if environment in PLEASE DON'T BE THE ONE TO DESTROY EVERYONE'S PEACE AND/OR SAFETY.

Security and Crime

- On 03 Jan 2018, a man was being chased by staff members of CJJ Steel in Strubenvale. I a desperate attempt to escape, he scaled our brick wall near the new suburb development between the estate and Welgedacht Road. He managed to get over the electric fence, triggering an alarm but not damaging the electric fence. He then scaled the precast wall with razor wire on top, into the property between the office and gate 3. We had at 10 GRA vehicles parked along the outside walls next to the roads, to prevent him from escaping onto the road, with residents on foot and in vehicles searching all construction sites and empty houses. But could not find him. Later that evening we had another fence alarm which we suspect was him scaling the brick wall to exit the property.
- 2) This has highlighted the fact that we need to look at upgrading our fence security, this point is on the agenda for discussion at the next operations meeting. If you

have any ideas regarding a cost-effective method of preventing such occurrences, please send them to me. clivebillowes@live.com.

We had person/s entering residents' gardens in the late hours of the night and early hours of the mornings, nothing was reported stolen, but this is of grave concern to us. We purchased for the security of living in the estate and someone is threatening that security. If your dogs suddenly start barking in the middle of the night, without switching on lights, look through your windows and report. Keep an eye on where the person goes so that we can try to find him. We do have residents that go out on such calls. Report on the WhatsApp security group or call me on 083 448 5825. Please, do not call unnecessarily as I also have a day job and leave for work
