## **Security and Crime**

Construction sites, empty houses and buildings are out of bounds, trespasses will be prosecuted.



We have had numerous complaints regarding contractors walking around the complex looking into houses and pedestrians walking through the boom gates.

Let us look at both these problems logically.

## Contractors walking around the complex

Every home/stand owner must sign a contractor's agreement before construction may begin. This contract covers all rules regarding contractors and their workers. One of the sections in this agreement states that contractor's workers must be driven to the construction site and that they may not roam around the complex.

### Pedestrians walking under the booms.

The boom gates have sensors in the road to detect motor vehicles passing under the booms, as soon as the vehicle has passed the boom, it automatically closes.

Now when a pedestrian passes through under the boom, the sensor does

not get activated and the boom only closes after timing out. This leaves the boom open for anyone to drive through, without a tag or the guard phoning a resident. This causes a significant security risk and cannot be allowed, we are going to issue non-compliance levies so please refrain from walking through booms, there are turnstiles for pedestrians. If you receive a visitor who is on foot the guard will ask you to press \*9, this will generate a code that will open the turnstile, one entry and one exit then the code expires.

# **Swimming Pool**

The monthly Pool Fee is stopped but we must still have access control.

<u>ALL residents who want to make use of the pool must purchase a tag at a once off price of R100.00 and sign the agreement of pool area rules and sign the indemnity document.</u>



We have had an alarming amount of complaints received by residents about the pool and peoples conduct in the pool area. Complaints ranging from Alcohol been taken into pool area in plastic bottles, Adults and children playing with the pool emergency equipment, playing football in the pool area making it very unpleasant for other residents enjoying the day out with the family and we have been advised of "Dagga" been smoked in hubbly bubbly's by people, together with the exceptional number of "outsiders" who do not live in the complex using the swimming pool. The swimming pool in the complex is for the use of residents and their family, it is **NOT** a public swimming pool area. Many home owners totally against this and call it abuse of the pool area, making it very uncomfortable for other residents using the pool area.

Due to the above mentioned GRA members and management and directors will be monitoring the daily happenings at the pool area over the festive season, and Non – Compliance fines will be issued to the perpetrators. This is "Our" pool lets look after it and adhere to the rules.

If you witness any of the above-mentioned concerns or any other rule been broken <u>PLEASE</u> report it to a GRA member or management for actioning, this is your safety and the safety of your children that we are fighting for, we cannot do it alone, we can only rectify and sort out the problems only if YOU as the homeowner / community assists. As always, your complaint will be treated with confidentiality.

- Pool tags may NOT be shared between houses if non-resident family Rule arrangements and indemnity documents MUST be signed.
- YOU are responsible for everyone you give access to the pool area
- **NO** more than five (5) persons to be tagged in on one tag, should you be having family around, arrangements with the office needs to be made, the office will inturn advise the members that are overseeing the pool for that day.
- Swimming pools are inherently dangerous, and no one wants injuries and or a fatality, there for the
  pool rules are NON negotiable and MUST be complied with at all times, when you purchased your
  tag. this was agreed to by the tag holder.
- In the interest of the safety of all, the offenders will be issued with non-compliance levies as stipulated and signed for in the pool rules. These rules and are **NOT** negotiable.
- Pool Rules can be seen on white notice board upon entering the access door and on the outer wall the pool area.

### **Pool Times**

Mondays CLOSED

Tuesday to Sunday 08:00 – 18:00

All efforts are made to keep the pool open during these hours, but GREHOA retain the right to close the pool, without prior notice, if necessary, for Maintenance and or Safety reasons should they arise.

## **Pool Rules**

- 1) NO Alcohol or drugs are allowed in or around the pool and parking area
- 2) NO Glass Containers
- 3) NO Loud music in pool or parking areas Consider the other swimmers!
- 4) NO Person is to swim alone Have a buddy go with you
- 5) NO running around the pool
- 6) NO Diving
- 7) NO Bombing
- 8) NO Dunking
- 9) NO Riding of bicycles in the pool area
- 10) NO Dogs
- 11) Fires are only permitted in braais provided Children under 12 may NOT enter the pool area unless actively supervised by a parent or custodian
- 12) POOL EQUIPMETN (SAFETY, CREEPIES & PIPES, PLASTIC COVERS, ELECTRICAL BOXES ETC.) MAY NOT BE PLAYED OR TAMPERED WITH AT ALL!!

Glass and alcohol are still being taken to the pool area in defiance of the rules, those not complying are going to be fined and even their access revoked.



## Speeding on our roads

Our house rules clearly state that the speed limit on our roads is 30Km/h. This rule was put in place to safeguard our children. There are not many places

in our country where children can safely play in the streets, this is a fact that we can be very proud of. Unfortunately,



we have a minority of residents who think they can speed around as they wish, this is an extremely selfish attitude and is not appreciated by the majority of residents. Every resident has the right to ask speedsters to slow down and report them to the office or Clive or Louis. Please if you do talk to someone who is speeding, do not be

rude, always treat the person with respect and do not get into an argument, rather walk away and report the person, recording the date, time, place and from or to which house the vehicle comes.

Our house rules also clearly state that

the board may impose levies (fines) on transgressors.
The house rules also state that residents are responsible for all guests you allow into the complex, this simply means that if

your visitor speeds, the noncompliance levy will be to your account **Transgression levies for speeding.** 1<sup>st</sup> offence R250.00 2<sup>nd</sup> Offence R500.00 Visitors will be escorted to the gate and will have to park outside with the resident receiving the non-compliance Repeat offenders will have their tags changed to pedestrian access (turnstile) only, they will have to park outside. Warnings may be issued..



PLEASE DON'T BE ONE OF THE FEW WHO ARE SPEEDING. ADHERE TO OUR SPEED LIMIT, you do not want to be the one who knocks a child over and you certainly do not want someone else to knock you child over.

Speeding is a serious threat to the safety of our children.

In the interest of the safety of all residents, pets and wild animals living on the estate, the discharging of fireworks is NOT PERMITTED

Anyone discharging fireworks will be issued a non-compliance fine of R500 without any verbal or written warning. If need be, we will call in the Metro

Police to issue fines as well.

Last year we had dogs badly injured while trying to escape the loud bangs, I even witnessed a person setting off fireworks right next to a baby in a pram, and while talking to a resident in phase 1, I watched his daughter who was holding one of those long tube-like fireworks, she lowered her arm to listen to me while the fireworks were still shooting out of the tube, but now all shooting against her father's Mercedes Benz standing in the driveway. I do not know if any damage was caused to the vehicle, but that could have been pointed at a person and serious injuries could have occurred.



#### Parties.

### We all enjoy a good party and we all would like to invite our friends to a party at our home.

This is not a problem at all if it is done in such a way as not to cause undue disturbance to your neighbours or any other residents in the estate.

Please inform the office if you are going to have a large number of vehicles coming into the gates.

- The office can, under certain circumstances, arrange a temporary entry/exit pin code instead of each guest having to phone in, Ts&Cs apply.
- Please inform your guests of the speed limit (30Kmh), as we can, and do, escort speedsters off the property and/or issue you with non-compliance levies, one per speeding vehicle.
- Please ask your guests not to wonder around the complex as this causes an issue with security, as we do not know who is legally

- on the estate and who has gained entry illegally.
- ❖ PLEASE, from 7 PM, start to turn your music down so that by 10pm it is soft enough not to be a nuisance to your neighbours. Complaints are attended to.
- It is not necessary to have music so loud that it is heard from many houses away.
