

Tuesday to Sundays 08H00 to 18H00

All efforts are made to keep the pool open during these hours, but we retain the right to close the pool, without prior notice, if necessary for safety or maintenance.

3. Pool Rules

- 1) POOL EQUIPMENT (SAFETY, CREEPIES & PIPES, PLASTIC COVERS, ETC.) MAY NOT BE PLAYED OR TAMPERED WITH!
- 2) No Alcohol or drugs are allowed in or around the pool and parking area.
- 3) No Glass containers
- 4) No Loud music in pool or parking areas
- 5) No Persons to swim alone
- 6) No Running
- 7) No Ball Games around the pool (soccer, etc.)
- 8) No Diving
- 9) No Bombing
- 10) No Dunking
- 11) No Riding of Bicycles in the pool area
- 12) No Dogs
- 13) Fires are only permitted in the braais provided
- 14) Children under 12 may not enter the pool area unless actively supervised by a parent or custodian

GRA members will patrol the pool area and have the right to check for Alcohol, drugs and glass containers
