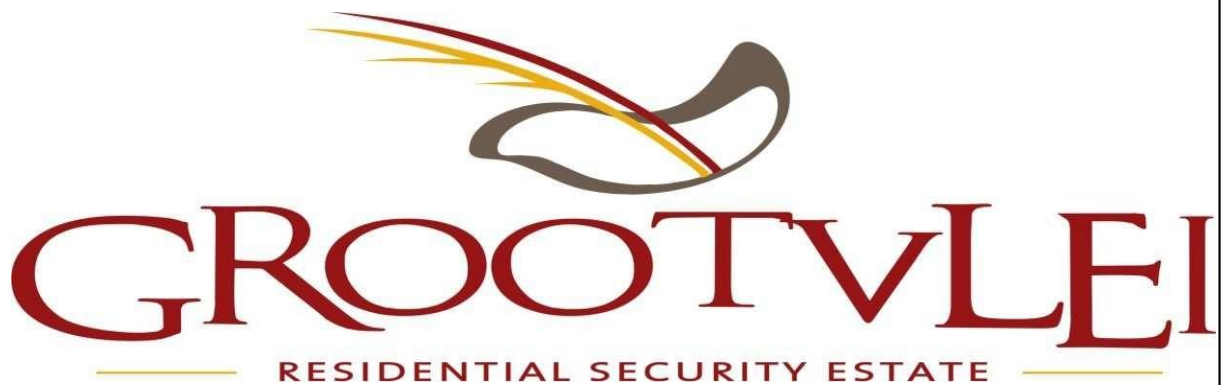

1. General undertaking

I _____ hereby acknowledge that there are no “life Guards” on duty at the swimming pool, and that using the swimming pool and all its facilities or equipment, is done so entirely at my own risk. I will ensure that anyone using my access, will not tamper with safety equipment. Neither GROOTVLEI RESIDENTIAL ESTATE HOME OWNER'S ASSOCIATION (hereinafter referred to as GREHOA, a company incorporated in terms of Section 21 of the Companies Act 61 of 1973) GRA or Fifth Season Investments or any of their staff/patrol members can be held liable for any injuries, loss or death that may occur.

I undertake to familiarize myself with the safety rules below and displayed at the pool and to adhere to these rules at all times. I also understand that I am responsible for any persons who enter the pool area using my access tag/code, and that I will ensure that all such persons adhere to the rules at all times

I undertake to inform the office immediately if I suspect my access code/tag is being used without my consent.

These Rules are subject to change from time to time at the discretion of the Trustees.

The pool is for the enjoyment of all residents, don't allow your enjoyment to affect others.

No-compliance of these rules will lead to non-compliance levies being issued,

1st – R500.00,

2nd - R 750.00,

3rd - Access revoked totally.

Tampering with safety equipment or notice boards - R500.00 and access suspended for 30 days.

2. Pool Times

01 September to 31 March
Mondays Closed
Tuesday to Sundays 08H00 to 18H00

All efforts are made to keep the pool open during these hours, but we retain the right to close the pool, without prior notice, if necessary for safety or maintenance.

3. Pool Rules

- 1) **POOL EQUIPMENT (SAFETY, CREEPIES & PIPES, PLASTIC COVERS, ETC.) MAY NOT BE PLAYED OR TAMPERED WITH!**
- 2) **No Alcohol or drugs are allowed in or around the pool and parking area.**
- 3) **No Glass containers**
- 4) **No Loud music in pool or parking areas**
- 5) **No Persons to swim alone**
- 6) **No Running**
- 7) **No Ball Games around the pool (soccer, etc.)**
- 8) **No Diving**
- 9) **No Bombing**
- 10) **No Dunking**
- 11) **No Riding of Bicycles in the pool area**
- 12) **No Dogs**
- 13) **Fires are only permitted in the braais provided**
- 14) **Children under 12 may not enter the pool area unless actively supervised by a parent or custodian**

GRA members will patrol the pool area and have the right to check for Alcohol, drugs and glass containers

5. Acceptance and Indemnity
